### Description of Program

A 29-month program for international dental graduates who are US citizens or permanent residents and are seeking to complete an accredited doctoral program in dentistry so as to be eligible for licensure to practice in the US. Following an initial 4-month review and intensive skills development course, students merge with the junior class to complete the final two years of the DDS curriculum.

### Requirements to apply to program

#### *English Language Proficiency*

- ✘ TOEFL test scores are required for all non-native English speaking applicants
- ✘ Internet-based TOEFL (iBT) scores are preferred
- ✘ Minimum 94 (iBT), suggested 100 (iBT) or above to be competitive
- ✘ Provide TOEFL information to ADEA CAAPID only; do not submit documentation to OUCOD

OUCOD institutional code is 6902. TOEFL scores more than 2 years are not accepted.

#### *National Board Dental Examination Requirements*

- ✘ Passing score on NBDE Part I
- ✘ NBDE Part II is optional but will be considered if score is provided
- ✘ Provide NBDE information to ADEA CAAPID only; do not submit test report(s) to OUCOD

#### *Advanced Dental Admission Test (ADAT)*

- ✘ Completion of the ADAT will not be considered during application review for admission to the program.

#### *Letter of Evaluation*

- ✘ Two Letters of Evaluation are required.
- ✘ One Letter of Evaluation should come from dean or senior administrator of dental school from which applicant graduated.
- ✘ Additional letter(s) from faculty at former dental school is preferred.
- ✘ Submit letters to ADEA CAAPID

#### *Transcripts and Evaluations*

- ✘ A **WES and ECE** course-by-course evaluation of transcript from dental school and any other colleges attended outside the U.S. is required. We currently require both WES and ECE evaluation.
- ✘ Official transcripts from all colleges or universities attended in the U.S. and Canada
- ✘ Submit evaluations and transcripts to ADEA CAAPID

#### *Other documents that should be sent directly to program (not to ADEA CAAPID)*

- ✘ [OU Supplemental Application](#) is submitted directly to the program
- ✘ OU Supplemental Application fee is approximately (\$103).
- ✘ Please submit the OU Supplemental Application/fee *at the time* you submit ADEA CAAPID application; **do not wait for a request.**

#### *Additional Requirements*

- ✘ Eligibility restricted to permanent residents and U.S. citizens who have completed a dental degree from a country outside the U.S. and Canada.

#### *Special Note*

- ✘ **Only applicants for whom we have received both the ADEA CAAPID application and the OUCOD Supplemental Application will be considered for admission**
- ✘ **Please do NOT submit original documents to OUCOD. Once a student is admitted, they are then required to submit original documents directly to our program (TOEFL scores, NBDE reports, proof of residency).**
