Dear Chairmen Rogers and Cochran and Ranking Members Lowey and Mikulski:

As your committees resolve the differences between your respective appropriations bills, we write to express our strong support for the restoration of Year-Round Pell Grants in the Fiscal Year 2017 Labor, Health and Human Services, Education, and Related Agencies appropriations bill, however it is incorporated into final FY17 funding legislation.

Pell Grants are critically important to ensuring access to postsecondary education for nearly eight million low- and middle-income students who depend on them to pursue their educations. In the last decade, benefits and eligibility for Pell Grants were repeatedly cut in response to funding shortfalls. This has resulted in hundreds of thousands of students losing their eligibility entirely, and others seeing their awards reduced. The loss of year-round Pell Grants after documented successes with the program was particularly troublesome.

As you are well aware, Year-Round Pell enjoys broad bipartisan support in Congress, near-universal endorsement among policy experts, and was included in the Senate bill. Year-Round Pell Grants were eliminated because Congress had to address an \$11 billion shortfall in the program at the time, not because of opposition to the policy itself. Now that the program has a projected \$7.8 billion surplus in FY17, the time is right to reinstate this provision and broaden access and opportunity for America's students.

Encouraging all eligible students—no matter their credit accumulation or enrollment intensity—to attend college year-round will expedite time-to-degree, significantly lower opportunity costs, and allow more rapid entry into the workforce. The language in the Senate

bill achieves these ends. It would therefore be entirely fitting to use the available surplus funding to restore this crucial benefit to needy students and return dividends to the nation in the form of accelerated degree attainment across sectors.

We thank you for your attention to this critical issue, and urge you to support America's students and restore Year-Round Pell Grants in the final FY17 appropriations.
