# Understanding the Transition Experiences of Full-time Allied Dental Educators

Simulation-based OSCEs: Building Resilience Through Innovative Faculty Calibrations

Faculty calibration continues to pose a significant challenge in clinical education due to varying opinions, evolving protocols and time limitations. Simulation-based Objective Structured Clinical Examinations (OSCEs) may offer a potential solution to address this issue. By creating realistic simulations of teaching scenarios using videos, calibrated typodonts and stations, we can identify common areas of inconsistency and create an intimate space for real-time self-reflection of deficiencies while enhancing faculty engagement and awareness of overall calibration. Consequently, this approach may help uphold the program's standards to improve student's success. Participants will gain valuable insights into the practical applications of OSCEs by empowering them to build resilience and continue to

push towards innovative ideas to improve faculty calibration within their respective programs.

Oral Health: An Evidence and Data-Driven Approach to Achieve Better Health, Equity, and Fiscal Responsibility

Dr. Chalmers will discuss long-standing oral health disparities in the prevalence of oral disease and access to oral health care services. Lack of access to preventive dental care can lead to costly emergency department visits. In addition, dental pain is one of the top reasons for opioid prescribing upon discharge from the emergency department. She will review opioid prescribing for dental needs and the impact of the COVID-19 pandemic on dental services utilization.

Dental Therapy: What It Is, What It Isn't, and Why Is It Important to Me?

Dental therapists have been working in the United States for almost 20 years. They are licensed oral health professionals who provide routine care, like exams and fillings. They are authorized to work in at least some settings in 13 states, and that number is rapidly growing,

Because any of our students could apply to dental therapy school, it's important that allied dental program directors understand who dental therapists are and what they do, and how to assist students who may be interested in this profession.
