Enhancing Our Students' Education Through an Accountable, Protected and Financially Sustainable CBCE Program

It is incumbent as a dental educator to open the eyes of the next generation of oral health care providers to a diverse portfolio of practice opportunities. These opportunities can enhance students' clinical education two- to three-fold, while generating a revenue stream for dental schools through accountable and financially sustainable programs. Engaging in a diverse portfolio of practice opportunities with outside industries will demonstrate how "Unity: Moving Forward Together" will result in "win-win outcomes" for all. The presentation will demonstrate how to implement and maintain a sustainable community-based clinical education (CBCE) program and address all the concerns and challenges schools have faced in the past. With data, we will address many myths in creating a financially sustainable CBCE program that enhances our students' clinical education.

Formed by the senior financial leaders of the Big Ten Conference dental schools and their teams, the Collaborative emerged from a shared commitment to addressing common challenges through data sharing, strategic dialogue and the exchange of best practices. We will highlight the conditions that led to its formation, how it adapted during the COVID-19 pandemic and the tangible outcomes it has delivered across member institutions. The session will showcase the practical benefits of sustained collaboration in enhancing operational performance and navigating complex issues. Attendees will be encouraged to reflect on these lessons and engage in discussion on how similar alliances—within or across institutions—can be created to promote innovation, strategic alignment and collective progress within the BFACA community.

- Discuss how to bridge the gap between business finance administration and clinic administration to create unified strategies for tackling industry-wide challenges, including fiscal constraints and clinical resource management.
- Describe techniques for breaking down complex issues, sharing knowledge across departments and implementing best practices that address both financial sustainability and clinical excellence.

When Dentistry Needs a Do-over: Managing Educational and Financial Ramifications

The Commission on Dental Accreditation (CODA) Standard 5-3 dictates that dental schools must conduct a formal system of continuous quality improvement and demonstrate “mechanism to determine the cause(s) of treatment deficiencies and ...

implementation of corrective measures as appropriate.”

Establishing structured processes for documenting deficiencies, their root causes and corresponding corrective measures can support institutions in setting benchmarks, standardizing clinical protocols and enhancing training for both students and faculty. Innovative workflows within electronic health records that systematically capture treatment deficiencies or adverse outcomes—along with their financial implications—can provide valuable insights. The resulting data can reveal trends in patient care, which may inform improvements in student education, faculty calibration, laboratory communication, material selection and overall clinical philosophies. This presentation will explore the management and outcomes of treatment deficiencies within an academic clinical environment.

- Describe strategies to bridge the gap between business finance and clinical administration to develop effective systems for tracking treatment deficiencies within a clinical educational environment.
- Identify practical strategies in addressing treatment deficiencies that enhance patient care and student learning outcomes.

Sustainable Clinical and Financial Models in Dental and Medical Education: A Systematic Review to Guide Innovation and Resilience

Funding cuts, particularly to Medicaid, and persistent insurance coverage gaps pose a significant threat to patient health care access, clinical operations and the quality of dental and medical education, especially in clinics serving underserved populations. Despite growing urgency, there is no comprehensive synthesis of evidence-based models that address the intersection of financial sustainability and clinical educational excellence. We propose to conduct a targeted systematic review to: (1) Highlight the impact of funding cuts and insurance gaps on patient access and clinical education quality, and (2) Identify and evaluate models of clinical efficiency, payment structures and operational resilience from dental and medical education clinics. This review will examine strategies that enable clinics to sustain high-quality patient care, ensure education quality and remain financially viable amid funding instability. This work will help guide strategic responses to current and future funding challenges in academic health care, highlighting the importance of collaboration across clinical and business units.

Learning Objectives

- Discuss the impact of Medicaid cuts and financial instability, including how reductions in funding and insurance gaps affect patient access, clinic sustainability and clinical education in dental schools.
- Describe innovative, evidence-based clinical and financial models from dental and medical education that improve care delivery and operational resilience.
- Explain how academic dental institutions can align clinical excellence with financial sustainability through cross-functional collaboration.
- List practical examples and early findings from the systematic review to inform local strategies for managing funding instability and enhancing clinic performance.
- Discuss how studies like this systematic review can continuously inform policy, planning and innovation across dental education institutions.

Through real-world examples, attendees will learn best practices for aligning simulation and clinic operations, co-developing customized student kits and implementing innovative procurement and training models. The session will also cover how integrated clinical management platforms and sterilization consultations support infection control compliance and sustainable growth. Emphasis is placed on phased implementation, cross-vendor coordination and

data-driven decision-making, all aimed at building resilient, future-ready educational environments.

In today's complex dental education environment, aligning financial management with clinical operations is essential for educational quality, patient care and institutional sustainability and excellence. This session explores collaborative strategies that bridge financial and clinical leadership, highlighting real-world case studies—including case data from the University of Oklahoma—where unified efforts and practical reforms have improved efficiency, patient care and fiscal performance.

Participants will learn best practices for integrating budgeting with clinical goals, using data analytics for strategic planning and implementing team-based decision-making. The session also delves into ATSU-ASDOH collaboration with Triton Medical

Solutions to illustrate practical solutions, such as outsourcing services and integrating medical-dental insurance billing, to optimizing operations. By refining internal workflows and embracing innovative approaches, dental schools can expand access to care, enhance student and resident experiences and strengthen financial outcomes. Through case-based learning, attendees will leave with actionable tools that promote collaboration, efficiency and cross-functional problem-solving, ultimately driving forward the educational, clinical and financial missions of academic dental institutions.
