Keynote Session:

The Economics of Health Care: Where Will the Future Lead Us?

Medicine and dentistry are often described as part of the same health care system, but they operate under very different economic models. Medicine has been shaped by third-party payment, large delivery systems, consolidation, government programs and policy oversight. Dentistry has historically remained more consumer-facing, practice-owner oriented and professionally autonomous, though some of those differences are narrowing.

In this opening conversation, health economist Anthony T. Lo Sasso will explore areas of convergence and divergence between medicine and dentistry, focusing on workforce dynamics, payment structures, ownership models, access and policy pressures. The session will consider what medicine's economic transformation may—and may not—imply for dentistry's future and what these trends mean for oral health education.
