#### Review of 2018 Fall Meetings

During the 2018 ADEA Fall Meetings in Toronto, Canada, ADEA COAEP hosted a robust educational program for members! Our program opened with a series of program director short talks where seven Canadian and U.S. advanced dental education program directors shared strengths and best practices in several areas, including recruiting and selecting applicants, promoting their programs, considerations for applicants from pass/fail schools, and the process for applicants applying to programs across the board. After the short talks concluded, we had a pair of speakers who shared insightful information on enriching dental postgraduate programs through a core curriculum in clinical research methodology.

With the Dental Match on the minds of program directors in the fall, we had a session providing an overview of the Match process, how programs might address post-Match openings, the differences between U.S. and Canadian procedures, and the opportunities the Dental Match creates for applicants and programs.

Our next session provided updates on the centralized application service for advanced dental education programs, ADEA PASS, and included a platform upgrade in 2019 with the advantages of using the service. The new resource, Dental School Grade Distributions, was also introduced and discussed.

We wrapped up our program with a Friday morning of hot topics in advanced dental education. The session included multiple relevant topics for faculty

in advanced education programs, including the ADA Advanced Dental Admission Test (ADAT), board certification and licensure, advising on student loan debt, graduate medical education (GME) funding and hospital credentialing.
