(Canadian dental schools may select Active or Affiliate membership). 2022

Affiliate. Affiliate Members must be based in the United States, Puerto Rico or Canada and may not be eligible for Active or Provisional membership. Affiliate members include:

- Canadian dental schools accredited by the Commission on Dental Accreditation of Canada.
